ATTORNEY GENERAL OPINION NO. 90- 18

Synopsis: An appointed member of the Emergency Medical  
Services Board may refuse his statutorily  
authorized per diem compensation by submitting a  
signed statement to the Chairman of the Board and  
thereby releasing the State from liability. Cited  
herein: K.S.A. 1989 Supp. 65-6102; K.S.A. 75-3223.

Dear Mr. Orth:

As Chairman of the Emergency Medical Services Board you  
inquire whether an appointed Board member may refuse his per  
diem compensation of \$35.00 a day. You also inquire whether  
the refusal should be addressed to a specific individual.

The statute that authorizes compensation for a member of the Emergency Medical Services Board is subsection (d) of K.S.A. 1989 Supp. 65-6102. It authorizes the payment of compensation, subsistence allowances, mileage and other expenses to members of the Board attending meetings or subcommittee meetings in accordance with K.S.A. 75-3223. It states in pertinent part:

"(a) Whenever it is provided by law that a member of a board is to receive compensation as provided in this section, such member shall be paid per diem compensation of thirty-five dollars (\$35) for each day of actual attendance at any meeting of such board or any subcommittee meeting authorized by such board. No per diem compensation shall be paid under this section to salaried state officers or employees except that whenever a member of the legislature is a member of a board he or she shall receive compensation as provided in K.S.A. 75-3212 and amendments thereto.

We will assume for purposes of your question that the Board member in question is not a member of the legislature. The statute above provides for the per diem compensation but does not address its refusal. A perusal of the statutes indicates there is no statute or regulation that prohibits the refusal of per diem compensation.

Subsection (f) of K.S.A. 1989 requires that all vouchers and all payrolls of the emergency medical services board be approved by the Board. Thus in order to receive the statutorily authorized per diem compensation the Board must submit the approved payroll to the Division of Accounts and Reports in the Department of Administration. If the approved payroll is not submitted for any entitled individual, the same is not paid and in effect, the payroll is refused. Thus it is our opinion that a Board member may refuse his per diem compensation by not having the agency submit an approved voucher of payroll to the Director of Accounts and Reports [in accordance with subsection (f) of K.S.A. 1989 Supp. 65-6102].

In answer to your second inquiry the Board member must submit a statement of rejection of his per diem compensation with language that he will release the state from any liability for payment therefrom. The statement must be addressed to the

Chairman of the Emergency Medical Services Board and make clear which of the statutorily authorized payments the Board member wishes withheld.

In conclusion we opine that a member of the Emergency Medical Services Board may refuse his per diem compensation for attending meetings by submitting a signed statement that releases the State from liability therefrom to the Chairman of the Board.
